// ELIGIBILITY REQUIREMENTS

- Discount is available to those racers who raced at least 75% of a qualifying race series in 2017 and intend to race a full 2018 season. Racers must provide proof of races raced.
- Racers that have not raced the 2017 season or have raced but not in a qualifying series must provide proof of racing a 2018 qualified series. Examples of proof include:
 - Pre-Registration (WORCS, BITD)
 - Membership (WORCS, SCORE, LOORS, BITD)
- New racers must also provide three references which can include:
 - Current Racers
 - Race Officials
 - Companies Involved In Racing
- All Racers who receive a discounted unit and do not compete in a 2018 qualified series will be billed for the remaining cost of the vehicle (at MSRP value).
- Racer qualifies for one discounted unit purchase if they compete in one of the following National Race Series:
 - Best in the Desert
 - SCORE International Off-Road Racing
 - World Off-Road Championship Series
 - Lucas Oil Off-Road Racing Series
 - Grand National Cross Country
- Discount or unit is not transferable
- Discount is available only to racers who have executed the forms set forth below and have been approved by emailing forms to PolarisFactoryRacing@polaris.com
- Sales registration for the unit must be on file with Polaris Industries Inc. prior to racing
- All Polaris logos must be predominantly displayed on the vehicle
- Discount will only be available to racers with a valid US mailing address
- Units must be new units purchased through a Polaris dealer
- Polaris reserves the right to make the final decision on eligibility to the program regardless of aforementioned eligibility and reserves the right to terminate the program at any time without prior notice.
- Discounts are as follows:
 - **\$5,000** off MSRP RZR XP units
 - **\$2,500** off MSRP RZR RS1 units
- A one time discounted parts order will also be eligible to racers who qualify for machine purchase up to \$5,000 MSRP value to be ordered directly by Polaris

// DISCOUNT CLAIM

2. Discount only available after:

- Polaris received the completed Discount Claim Form
- Proof of racing at least 75% of 2017 qualifying races is submitted or new racer provides proof of 2018 registration and references
- Polaris will contact the racer for payment which must be received before unit will be ordered

3. Falsification of claim forms will result in future disqualification from any racing programs. Polaris Discount Racing program qualification and details are subject to change without any notice.

4. In all matters concerning the interpretation of the Polaris Discount Racing program, the decision of Polaris is final.

5. Polaris has the right to cancel or modify this program anytime, without prior notice.

RELEASE, LIABILITY WAIVER, INDEMNIFICATION AND ASSUMPTION OF RISK

In consideration of being considered to participate in the Polaris Racing Discount Program, I, the undersigned, for myself, successors, heirs and assigns, release, waive liability, promise never to sue, and forever discharge, Polaris Industries Inc. (Polaris) and its affiliates, agents, employees, servants, officers, directors, and authorized Polaris dealers ("Released Parties") from all claims, including but not limited to claims for negligent acts or omissions, actions or judgments I may have or claim to have against Polaris and related parties. I agree that I am responsible for all personal injuries, including death, and injuries to property, real or personal, caused by or arising out of my participation in the Polaris Contingency Program.

I understand that ATV racing is inherently dangerous. I represent to Polaris that I have had sufficient experience riding SxSs to understand all the risks involved in SxS racing. I expressly and voluntarily assume all risk of personal injury or death sustained while participating in the Program, whether or not caused by the negligence or other fault of Released Parties, or any of them, including but not limited to equipment malfunction from any cause, inadequate training or supervision, defective design of equipment or ATV race course, failure to keep safe, failure to investigate or supervise other riders, or failure to warn of potential risks.

I further agree for myself, my successors, heirs and assigns to indemnify and hold the Released Parties harmless from all claims and suits for personal injuries, including death, and damages to property caused by my act or omission arising out of my participation in the Polaris Racing Discount Program, and from all judgments recovered and from all expensed incurred in defending said claims or suits.

I am in good health and have no physical conditions that would prevent me from participating in the Polaris Racing Discount Program.

I further agree to that without compensation, my name, as well as any photographs, pictures, slides, or movies taken of myself or made in connection with my participation in the Polaris Racing Discount Program, or any reproduction of the same, may in any manner be used by Polaris, or by any person, corporation or association authorized by Polaris.

I understand that I am giving up substantial rights by signing this document. I agree to abide by all the eligibility requirements as listed in the eligibility requirements on the previous page.

I agree to use all recommended safety equipment and to abide by all warnings and safety recommendations of Polaris. I agree that I will not race while under the influence of alcohol or drugs.
