

2020 POLARIS® OUTLAW® 70 EFI GIVEAWAY COMPLETE OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ENTER BETWEEN MARCH 5, 2020 AND MAY 31, 2020. Open only to legal residents of the **United States, District of Columbia and Canada (excluding Quebec)** who, at the time of entry, are 18 years of age or older and who have reached the age of majority in their state or province of residence. Void outside the U.S. and Canada or where prohibited or restricted by law. This sweepstakes ("Sweepstakes") is subject to all applicable federal, state, and local laws and regulations.
