# **BENNINGTON LIMITED WARRANTY MODEL YEAR 2026**

POLARIS BOATS LLC ("POLARIS BOATS") gives the following Limited Warranty on all components of your Bennington boat against defects in materials or workmanship supplied by or performed by BENNINGTON, unless otherwise excluded below. This warranty covers parts, and labor charges for repair or replacement and begins on the date of purchase by the original retail purchaser through a qualified facility. The duration of this warranty may vary by international region based upon local laws and regulations.

Additional boat component warranties may be provided by the respective manufacturers directly. Such warranties may be found in Owner's package or by contacting BENNINGTON'S Customer Service Department (see bottom of this document). BENNINGTON is not responsible for and will not pay for or honor any such warranties regardless of whether the boat is being used for noncommercial or commercial use. Components that are covered by another manufacturer's warranty are hereby expressly excluded under the terms of this Limited Warranty.

#### A. WHAT IS COVERED AND COVERAGE PERIOD

#### 1. Non-Commercial Boat Use:

For non-commercial boat use (e.g., retail consumer sales and leases that are used solely for recreational, personal consumer use) POLARIS BOATS will warrant the BENNINGTON brand against material defects in materials or workmanship supplied by or performed by Bennington as follows:

LIMITED LIFETIME WARRANTY: BENNINGTON provides a limited lifetime warranty against:

- Structural failure on pontoon tubes, gates, motor mounts, railings, under decks
- Wooden decks
- Wood components

which fail as a result of defects in material and or workmanship by BENNINGTON under normal, non-commercial use. At its discretion, BENNINGTON will authorize the repair or replace the items listed under this Limited Lifetime Warranty.

LIMITED TEN (10) YEAR WARRANTY: For a period of Ten (10) Years, BENNINGTON will warrant against defects for:

- Deck covering and fabric due to excessive fading, peeling, or cracking. BENNINGTON shall be solely responsible for determining what qualifies as "excessive" pursuant to industry standard. This warranty shall include replacement materials and labor.
- BENNINGTON also warrants all other factory parts and components, not excluded below, against material defects in materials or workmanship supplied by or performed by BENNINGTON. At its discretion, BENNINGTON will authorize the repair or replacement of the items listed under this Limited Warranty.

Excessive deterioration caused by overexposure to the elements as a result of improperly covering the boat may be excluded from this warranty. Damage resulting in rips, tears, snags, and unraveling or other abuse is not covered under this warranty.

**LIMITED TEN (10) YEAR WARRANTY:** For a period of Ten (10) Years, BENNINGTON will warrant factory installed electronic products, not excluded below, against material defects in the materials or workmanship supplied by or performed by BENNINGTON. At its discretion, BENNINGTON will authorize the repair or replacement of the items listed under this Limited Warranty that matches in form and function. This electronics warranty does not cover replacement of non-defective components in the event that form factor of the electronics item changes size, shape, or color.

#### 2. Transferability

To the extent that the original end-consumer transfers this warranty to a second end-consumer, that second end-consumer shall only receive the benefits under this warranty for a maximum of five (5) years after the original end-consumer's original purchase warranty registration date. An end-consumer, under the applicable laws, includes and only includes a buyer (other than for purposes of resale) of POLARIS BOATS who will use the boat; any person to whom such product is transferred during the duration of the applicable warranty; and any other person who is entitled by the terms of such warranty or under applicable law to enforce against POLARIS BOATS the obligations of the warranty. These warranties shall thus not apply to any reseller of Bennington boats.

#### 3. Commercial Boat Use:

For commercial boat use (e.g., rental fleets, tour boats, charter boats, demonstrators, subscriptions, or in the event a consumer purchaser uses his/her/its boat for non-personal or non-recreational personal use) POLARIS BOATS will warrant the brand against material defects in materials or workmanship supplied by or performed by BENNINGTON for all parts and components, not otherwise excluded, for a period of two (2) years from the date of the original purchase. At its discretion, BENNINGTON will repair or replace the items listed under this Limited Warranty

#### B. REGISTRATION

At the time of sale, the Warranty Registration Form must be completed by your dealer and submitted to BENNINGTON within <u>fifteen (15) days</u> of purchase. Upon receipt of this registration, BENNINGTON will record the registration for warranty. No verification of registration will be sent to the purchaser as the copy of the Warranty Registration Form will be your proof of warranty coverage. If you have not signed the original registration and received the customer copy, please contact your dealer immediately. Initial dealer preparation and set-up of your boat is very important in ensuring trouble-free operation.

Should a boat remain in a dealer's inventory for longer than a period of two years, warranty coverage will automatically commence two years from the wholesale delivery date.

#### C. WARRANTY EXCLUSIONS

This BENNINGTON Limited Warranty excludes any failures that are not caused by a defect in material or workmanship. THIS WARRANTY DOES NOT COVER CLAIMS OF DEFECTIVE DESIGN.

This Limited Warranty also does not cover acts of God, accidental damage, normal wear and tear, abuse or improper handling. This warranty also does not cover damage to any boat, component or part as a result of being altered structurally, modified, neglected, improperly maintained or used for racing, competition or purposes other than for which it was designed.

This Limited Warranty excludes damages or failures arising out of or related to: improper lubrication; improper fuel; surface imperfections caused by external stress, heat, cold or contamination; operator error or abuse; improper component alignment, tension, adjustment or altitude compensation; snow, water, dirt or other foreign substance ingestion/contamination; batteries, engines, props and outdrives; gelcoat crazing and osmotic blistering; electrolysis, stray-current or galvanic corrosion; failure to perform or improper maintenance; damage or fading to interior surfaces (upholstery and flooring) as a result of prolonged exposure to direct sunlight and failure to cover the boat when the boat is not in use; damage caused by pooling of water on covers, trailering with canvas on boat (all canvas should be removed prior to trailering), damage or performance issues resulting from the use of aftermarket accessories designed to lift boat from the water (example: SeaLegs), damage or performance related issues resulting from the installation of shallow water anchoring systems, damage to interior surfaces caused by sunscreen sprays; unapproved cleaners; fabric rips, tears, snags and unraveling; ToonTint, shark hide or like aluminum coating protectants; surface scratches caused by normal wear and tear; modified components and parts; lack of compliance with Owner's Manual; use of equipment that exceeds load capacities, certification or horsepower; failure to trim boat properly; improper or prolonged storage; submersion in water; corrosion or cosmetic damage; damage from towing behind other boats or improper trailering; use of non-factory installed, aftermarket or unapproved components, accessories, equipment or appliances; equipment and appliances (e.g., engines, outdrives, propulsion systems) not manufactured by BENNINGTON; unauthorized repairs or disassembly; or repairs made after the warranty period expires or by an unauthorized repair center.

This warranty excludes any accessories which utilize exterior rail channels or other channel based mounting systems, including but not limited to Click and Cruise. This coverage excludes damage resulting from the use of these accessories, their parts or components and damage caused by rubbing, scuffing, denting or dings associated with those products use or misuse. These accessories and their subcomponents are excluded regardless of how they are purchased or the timeframe which they are purchased. For Click and Cruise Warranty, please refer to Parts and Accessories Warranty.

This Limited Warranty excludes damages or failures caused by abuse, accident, fire or any other cause other than a defect in materials or workmanship (e.g., pets and other animals) and provides no coverage for consumable components, general wear and routine service items (e.g., light bulbs, fuses, lubricants), or any parts exposed to friction surfaces, stresses, temperature variations (e.g., infrared heaters and other high output heat sources), environmental conditions (e.g., saltwater, mold, mildew, hail, road salt, freeze damage, sun damage, thermal cracking) and/or contamination for which they were not designed or not intended.

Power Washers should never be used on any portion of the boat. Any use of a power washer will void the warranty. Bimini tops are not designed for high speed. Any damage sustained due to an open Bimini, be it while towing or driving on the water, over 25 MPH will not be considered a warrantable failure.

This limited warranty will be voided by the addition of customer installed accessories that change the center of gravity of the boat, structural integrity of the boat or a portion of the boat. These items include hydrofoils, boat lifts that permanently attach to the boats structure or super structures that are added by the consumer.

This Limited Warranty provides no coverage for personal loss or expense, including but not limited to mileage, transportation costs, towing expenses, hotels, meals, shipping or handling fees, boat pick-up or delivery, replacement rentals, loss of boat use, loss of profits, or loss of vacation or personal time. Replacement Parts provided under terms of the warranty will, at the discretion of Bennington, match original equipment but no guarantee is made as to the ability to do so. When necessary, Bennington will substitute parts of comparable function or value. Bennington will not be responsible for any sums exceeding the cost of defective part or product.

This warranty does not cover any Bennington product that is damaged as the result of electrolysis, stray current corrosion or galvanic corrosion or any such corrosion that results from the lack of maintenance of, and/or use of incorrect sacrificial anodes. Corrosion can occur under many different circumstances in and out of the water which would not be covered under this limited warranty. Electrolysis can cause severe structural damage to a boat and its accessories. To prevent corrosion, precautions should

be taken including but not limited to sacrificial anodes, anti-fouling paint, limited exposure to saltwater, trailers with plastic tread bunks (do not use carpeted bunks). Fully wash the boat, tubes and cross members immediately after every usage in saltwater.

### D. LIMITATION OF LIABILITY

The exclusive remedy and sole liability under this warranty shall be, at BENNINGTON'S option, to repair or replace any defective materials, components or products. THE REMEDIES SET FORTH IN THIS LIMITED WARRANTY ARE THE EXCLUSIVE AND SOLE REMEDIES AVAILABLE TO ANY PERSON FOR BREACH OF THIS WARRANTY. BENNINGTON SHALL HAVE NO LIABILITY TO ANY PERSON FOR ANY INJURY TO OR LOSS OF GOODWILL, REPUTATION, BUSINESS, PRODUCTION, REVENUES, PROFITS, ANTICIPATED PROFITS, CONTRACTS, OR OPPORTUNITIES (REGARDLESS OF HOW THESE ARE CLASSIFIED AS DAMAGES), OR FOR ANY CONSEQUENTIAL, INCIDENTAL, INDIRECT, EXEMPLARY, SPECIAL, PUNITIVE, OR ENHANCED DAMAGES WHETHER ARISING OUT OF BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY, PRODUCT LIABILITY, OR OTHERWISE. THIS EXCLUSION OF CONSEQUENTAL, INCIDENTAL, AND SPECIAL DAMAGES IS INDEPENDENT FROM AND SHALL SURVIVE ANY FINDING THAT THE EXCLUSIVE REMEDY FAILED OF ITS ESSENTIAL PURPOSE.

NO EXPRESS WARRANTY IS GIVEN BY BENNINGTON EXCEPT AS SPECIFICALLY SET FORTH HEREIN. **TO THE GREATEST EXTENT PERMITTED BY LAW, ALL OTHER WARRANTIES, INCLUDING ANY IMPLIED WARRANTIES, WARRANTIES OF MERCHANTABILITY, AND WARRANTIES FOR FITNESS FOR A PARTICULAR PURPOSES ARE HEREBY EXPRESSLY EXCLUDED.** THE FOREGOING STATEMENTS OF WARRANTY ARE EXCLUSIVE AND IN LIEU OF ALL OTHER REMEDIES. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATIONS MAY NOT APPLY. SOME STATES DO NOT PERMIT THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES OR ALLOW LIMITATIONS ON THE DURATION OF IMPLIED WARRANTIES, SO THE ABOVE LIMITATIONS MAY NOT APPLY.

ANY LEGAL CLAIM ARISING OUT OF OR RELATED TO THIS LIMITED WARRANTY MUST BE BROUGHT WITHIN TWO (2) YEARS OF THE DATE YOU FIRST EXPERIENCED THE ISSUE WITH THE BOAT. FAILURE TO BRING A CLAIM WITHIN TWO YEARS AFTER YOU FIRST EXPERIENCED THE ISSUE WITH THE BOAT WAIVES ANY RIGHT TO BRING A LEGAL ACTION FOR THAT ALLEGED DEFECT.

#### E. LEGAL RIGHTS

THIS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE. IF ANY OF THE ABOVE TERMS ARE VOID BECAUSE OF FEDERAL, STATE OR LOCAL LAW, ALL OTHER LIMITED WARRANTY TERMS WILL REMAIN IN EFFECT.

#### F. GOVERNING LAW AND VENUE; SEVERABILITY

To the fullest extent permitted under applicable law, this Limited Warranty and any disputes arising out of this warranty shall be governed by the laws of the State of Minnesota, excluding conflicts of law principles and excluding the Convention for the International Sale of Goods. Any dispute arising under or related to this Limited Warranty or any claim for breach of this Limited Warranty shall be resolved exclusively through binding arbitration administered by the American Arbitration Association ("AAA") and conducted in Minnesota. If any provision of this warranty is unlawful, void or unenforceable, that provision shall be deemed severable and shall not affect any remaining provisions. In the event it is determined that any matter arising out of or related to this Agreement is not subject to binding arbitration, the parties agree that the exclusive venue for any court action is in the state or federal courts in Minnesota. Parties agree to consent to the personal jurisdiction of any state or federal court in Minnesota and will not challenge the forum based on the convenience of the parties.

#### G. HOW TO OBTAIN WARRANTY SERVICE

If your boat requires warranty service, you must take it to a qualified BENNINGTON repair facility. When requesting warranty service, you must present your copy of the Warranty Registration Form to the dealer. THE COST OF TRANSPORTATION TO AND FROM THE DEALER IS YOUR RESPONSIBILITY. You are responsible for presenting your boat to a dealer as soon as a problem exists. The warranty repairs should be completed in a reasonable amount of time. However, any damage caused to the product by you or any non-authorized third party may void this warranty. Warranty or Service Bulletin repairs must be done by a qualified facility

#### 1. IN THE COUNTRY WHERE YOUR BOAT WAS PURCHASED:

Warranty or Service Bulletin repairs must be done by a qualified facility. If you move or are traveling within the country where your boat was purchased, Warranty and Service Bulletin repairs may be requested from a qualified facility.

#### 2. OUTSIDE THE COUNTRY WHERE YOUR BOAT WAS PURCHASED:

If you are traveling temporarily outside the country where your boat was purchased, you should take your boat to a qualified facility. You must show the dealer photo identification from the country of the selling dealer's authorized location as proof of residence. Upon residence verification, the servicing dealer will be authorized to perform the warranty repair.

#### 3. IF YOU MOVE:

If you move to another country, be sure to contact BENNINGTON Customer Assistance and the customs department of the destination country before you move. Boat importation rules vary considerably from country to country. You may be required to present documentation of your move to BENNINGTON in order to continue your warranty coverage.

#### IF YOU PURCHASE FROM A PRIVATE PARTY:

If you purchase a BENNINGTON boat from a private party, to be kept and used outside of the country in which the boat was originally purchased, all warranty coverage will be denied.

## 4. EXPORTED BOATS

EXCEPT WHERE SPECIFICALLY REQUIRED BY LAW, THERE IS NO WARRANTY OR SERVICE BULLETIN COVERAGE ON BOATS SOLD OUTSIDE THE COUNTRY OF THE SELLING DEALER'S AUTHORIZED LOCATION. This policy does not apply to boats that have received authorization for export from BENNINGTON. Dealers may not give authorization for export. You should consult an authorized dealer to determine your boat's warranty or service coverage if you have any questions. This policy does not apply to boats registered to government officials or military personnel on assignment outside the country of the selling dealer's authorized location. This policy does not apply to Safety Bulletins.

#### 5. NOTICE

If your boat is registered outside of the country where it was purchased and you have not followed the procedure set above, your boat will no longer be eligible for warranty or service bulletin coverage of any kind, other than safety bulletins. Boats registered to Government officials or military personnel on assignment outside of the country where the boat was purchased will continue to be covered by the Limited Warranty.

Please work with your dealer to resolve any warranty issues. Should your dealer require any additional assistance, they will contact the appropriate person at BENNINGTON.
