

**2022 POLARIS® NATIONAL GET OUTDOORS DAY SWEEPSTAKES
COMPLETE OFFICIAL RULES**

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ENTRY FORM AVAILABLE AT POLARIS® WEBSITE:

Open only to legal residents of the **United States and District of Columbia**, who, at the time of entry, are 18 years of age or older and who have reached the age of majority in their state of residence. 2. HOW TO ENTER.
