

2023 PolarisXPEDITION® SWEEPSTAKES COMPLETE OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ENTRY FORMS AVAILABLE AT MANY PARTICIPATING POLARIS® EVENTS BETWEEN MAY 16, 2023 AND DECEMBER 31, 2023.

2. ELIGIBILITY: The Sweepstakes is open to: i) legal permanent residents of the fifty (50) United States (including the District of Columbia) who are eighteen (18) years of age or older or the age of majority in his/her state of residence, or ii) a legal resident of Canada (excluding residents of the province of Quebec) and at least the age of majority in his/her province or territory of residence at the time of entry (the "entrant"). Persons in any of the following categories are **not** eligible to participate or win a prize: (a) persons who, since May 16, 2023 were or are employees, officers, directors or agents of Polaris Industries Inc. (the "Sponsor") or National Sweepstakes Company, LLC (the "Independent Administrator"); their parent companies, affiliates, subsidiaries, or dealers; or the service agencies of any of the above organizations; (b) individuals engaged in the development of, the production or distribution of materials for, or the implementation of this Sweepstakes; or (c) employees of, persons in the immediate family of, or persons living in the same household as any person in any of the preceding categories. 3. HOW TO ENTER.

There are two ways to enter this Sweepstakes. 1) Complete the entry form on the Polaris website at <https://www.polaris.com/en-us/off-road/sweepstakes/polaris-xpedition-giveaway/> or 2) Visit a Polaris Booth at a participating Polaris® event to complete the entry form by using the iPad. Entrants must complete the entry form in its entirety to include: full name; complete address, daytime phone number, including area code; and e-mail address. Entrant must agree to the Official Rules in order to submit and receive one (1) entry into the Sweepstakes. Limit of one (1) entry per person or email address. All entries must be received and recorded between 12:00 a.m. Central Time (CT) on May 16, 2023 and 11:59 p.m. CT on December 31, 2023. (the "Sweepstakes Period") to be eligible. Multiple entries per person or email address are prohibited. Only one entry will be considered a valid entry from any entrant. Once submitted, entries become the property of Sponsor and will not be returned.

Limit of one (1) entry per person for the Sweepstakes. Sponsor is not responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible entries or for inaccurate entry information, whether caused by the participant or by any of the equipment or programming associated with or utilized in this Sweepstakes, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's computer system. Participant must notify Sponsor of any changed contact information within the Sweepstakes Period to remain eligible to win based on entry information. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, programmed or similar response methods will void all such entries submitted by such methods. Each entry must be manually key stroked and manually entered by the individual entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified. All entries must be completed by the individual entrant and not by any other party.

4. DRAWING/ODDS: On or about January 31, 2024 at 2:00pm Eastern Time in Newark, NY, one (1) grand prize winner (the “Grand Prize Winner”) will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. The odds of being selected as the Grand Prize Winner is dependent upon the number of eligible entries received during the Sweepstakes Period. The random drawing will be conducted by the Independent Administrator, whose decisions are based upon its sole discretion and interpretation of these Official Rules and are final and binding in all respects.

5. GRAND PRIZE NOTIFICATION/CLAIM: Award and confirmation of the Grand Prize Winner is contingent upon potential Grand Prize Winner’s qualification and compliance with these Official Rules. Potential Grand Prize Winner will be notified by email and telephone (the “Notification”). Before being declared a Grand Prize Winner, the potential Grand Prize Winner must respond to the Notification within the time frame indicated by providing a completed Affidavit of Eligibility/Liability/Publicity Release Form and an IRS Form (the “Required Documents”). Grand Prize Winner will be solely responsible for any applicable registration, license, title and insurance fees, all taxes (federal, state, local, sales and/or income) and any expenses not listed herein related to the acceptance and use of the Grand Prize. Grand Prize will have a standard factory warranty. Any difference between stated MSRP and actual value of the vehicle will not be awarded. Total ARV of the Grand Prize is \$49,499USD/\$60,964CAN.

Grand Prize Winner will take delivery of the Grand Prize at a Polaris dealer as designated by Sponsor within thirty (30) days of notification that Grand Prize is available. Winner must have or obtain and provide proof of liability insurance prior to the time of delivery of the Prize. In the event of noncompliance, the Grand Prize will be forfeited and an alternate potential Grand Prize Winner will be selected from the remaining eligible entries received during the Sweepstakes Period.
