DATES: Giveaway starts on August 15, 2024 at 8:00 am Central Standard Time (CT) and ends at 11:59 pm CT on August 24, 2024 (“Giveaway Period”). The Giveaway Period is subject to change at Sponsor’s discretion if for any unforeseen reason the Giveaway cannot be conducted as planned. All times are Central Standard Time. Sponsor’s computer will be the official time clock for the Giveaway.

ELIGIBILITY: Open only to legal residents of the fifty (50) **United States, District of Columbia and Canada (excluding Quebec)** who, at the time of entry are 18 years of age or older and who have reached the age of majority in their place of residence (the “Entrant”).
