

**KOLPIN® OUTDOORS 2023 SUMMER SWEEPSTAKES
OFFICIAL RULES**

SPONSOR. The Sponsor of the KOLPIN® OUTDOORS 2023 SUMMER SWEEPSTAKES (“**Sweepstakes**”) is Polaris Industries Inc. (“**Sponsor**”), 2100 Hwy 55, Medina, MN 55340.
