

**POLARIS GET OUTDOORS DAY GIVEAWAY (THE “SWEEPSTAKES”)
COMPLETE OFFICIAL RULES**

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

2. ELIGIBILITY: The Sweepstakes is open to legal permanent residents of the forty-eight (48) contiguous United States (including the District of Columbia) who are eighteen (18) years of age or older at the time of entry (the “entrant”). Persons in any of the following categories are **not** eligible to participate or win a prize: (a) persons who, since June 1, 2024 were or are employees, officers, directors or agents of Polaris Industries Inc. (the “Sponsor”) or National Sweepstakes Company, LLC (the “Independent Administrator”); their parent companies, affiliates, subsidiaries, or dealers; or the service agencies of any of the above organizations; (b) individuals engaged in the development of, the production or distribution of materials for, or the implementation of this Sweepstakes; or (c) employees of, persons in the immediate family of, or persons living in the same household as any person in any of the preceding categories. For the purpose of this Sweepstakes, “immediate family members” are defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children, and grandchildren. Void outside the forty-eight (48) contiguous United States, the District of Columbia and where prohibited or restricted by law. 3. SWEEPSTAKES PERIOD: The Sweepstakes will start at 12:00:00 am Central Standard Time (“CT”) on June 1, 2024 and end at 11:59:59pm CT on June 30, 2024 (the “Sweepstakes Period”).

4. HOW TO ENTER. Visit <https://www.polaris.com/national-great-outdoors-month/weekend-getaway/> (the “Website”) and complete the online entry form. Entrants must complete the entry form in its entirety to include: first name; last name, email address, phone number, address, city, state and postal code. Entrant must agree to the Official Rules in order to submit and receive one (1) entry into the Sweepstakes. Limit of one (1) entry per person or email address. All entries must be received by 11:59:59 p.m. CT on June 30, 2024 to be eligible. Multiple entries per person or email address are prohibited. Only one entry will be considered a valid entry from any entrant. Once submitted, entries become the property of Sponsor and will not be returned.

Limit of one (1) entry per person for the Sweepstakes. Sponsor is not responsible for lost, misdirected, late, unsent, incomplete, or unintelligible entries or for inaccurate entry information, whether caused by the entrant or by any of the equipment or programming associated with or utilized in this Sweepstakes, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the entrant’s computer system. Entrant must notify Sponsor of any changed contact information within the Sweepstakes Period to remain eligible to win based on entry information. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, programmed or similar response methods will void all such entries submitted by such methods. Each entry must be manually key stroked and manually entered by the individual entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified. All entries must be completed by the individual entrant and not by any other party.

5. DRAWING/ODDS: On or about July 2, 2024, four (4) grand prize winners (each a “Grand Prize Winner”) will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. The odds of being selected as the Grand Prize Winner is dependent upon the number of eligible entries received during the Sweepstakes Period. The random drawing will be conducted by the

Independent Administrator, whose decisions are based upon its sole discretion and interpretation of these Official Rules and are final and binding in all respects.

6. GRAND PRIZE NOTIFICATION/CLAIM: Award and confirmation of the Grand Prize Winner is contingent upon potential Grand Prize Winner's qualification and compliance with these Official Rules. Potential Grand Prize Winner will be notified by email and telephone (the "Notification"). Before being declared a Grand Prize Winner, the potential Grand Prize Winner must respond to the Notification within the time frame indicated by providing a completed Affidavit of Eligibility/Liability/Publicity Release Form and an IRS Form (the "Required Documents"). Guest of Grand Prize Winner will need to complete a travel companion waiver form prior to dates of travel. Sponsor reserves the right, in its sole discretion, to disqualify and randomly select an alternative potential Grand Prize Winner if: (a) the potential Grand Prize Winner does not respond within the Notification timeframe; (b) the Notification is returned as undeliverable; (c) the potential Grand Prize Winner fails to provide Sponsor with satisfactory proof of age, identity, residency or eligibility or provide the Required Documents; (d) the potential Grand Prize Winner declines acceptance of the Grand Prize; and (e) if in Sponsor's determination, the potential Grand Prize Winner has not complied with these Official Rules.

Total Approximate Retail Value of each Grand Prize is \$3,500.

9. DISPUTES. THIS SWEEPSTAKES IS GOVERNED BY THE LAWS OF THE STATE OF NEW YORK WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in this Sweepstakes, each entrant agrees that any and all disputes that cannot be resolved between the parties and causes of action arising out of or connected with this Sweepstakes shall be resolved individually, without resort to any form of class action, exclusively before a court located in New York, having jurisdiction over the parties and the subject matter.
