

**“2026 Polaris 1776 Custom Build Vehicle” Contest (the “Contest”)
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN.

DATES OF CONTEST: The Contest begins at 12:00 a.m. Eastern Standard Time (“ET”) on June 4, 2026 and ends at 11:59 p.m. ET on July 6, 2026 (“Contest Period”). For purposes of these Official Rules, all times given are in Eastern Standard Time (“ET”).

SPONSOR: Polaris Industries Inc., 2100 Highway 55, Medina, MN 55340.

ELIGIBILITY: The Contest is open to legal permanent residents located within the fifty (50) United States or the District of Columbia who are eighteen (18) years of age or older (the “Nominator”). The Nominator will nominate a person who exemplifies being a hero (the “Nominee”). Nominator may nominate themselves. The Nominee determined in the judging process will be the prize winner. Employees and their immediate family members (parents, children, siblings or spouse, regardless of where they live, or persons living in same household, whether related or not) of Sponsor and its respective parent companies, divisions, affiliates, subsidiaries, distributors, advertising and Contest agencies, and any others engaged in the development, production, execution or distribution of this Contest, including but not limited to National Sweepstakes Company, LLC and the entities supplying the prizes herein (all of the aforementioned collectively referred to as the “Contest Entities”), are not eligible to participate. Contest is subject to all federal, state, and local laws and regulations, without regard to conflict of law provisions. Contest is void outside of the fifty (50) United States, the District of Columbia and wherever else restricted or prohibited by law. By entering this Contest, the Nominators and Nominees indicate their full and unconditional agreement to and acceptance of these Official Rules and the decision of the Sponsor, which are final and binding in all respects. Winning is contingent upon fulfilling all requirements set forth herein.

HOW TO ENTER: Visit <https://www.polaris.com/en-us/off-road/sweepstakes/celebrate-american-heroes> the “Website” and complete the online entry form on the Website landing page and provide/submit a written statement about why the Nominator or Nominee is eligible with a unique story and a photo showing why the nominating person exemplifies being a hero (the “Submission”). Nominator must complete the online entry form in its entirety to include name, address, phone number, email address and category. Written statement must be 5,000 words or less. Upon completing the Submission, click the “Enter Now” button to receive one (1) Submission into the Contest.

Photos should be no larger than 10MB and must be submitted in JPG format. Photos should only be of the Nominee not contain any third-party persons unless third party persons have signed a release form. Nominator may be asked by Sponsor to provide the third-party release form for any advertising/promotional purposes in connection with the Contest. Any photo that contains third party persons in which a release cannot be provide, the Submission will be disqualified.

There is a limit of one (1) Submission per Nominee for the Contest. The first Submission submitted based on the date and time stamp will be the Submission that is judged.

Neither Sponsor, nor any other Contest Entity, are responsible for any Submission that is lost, late, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions or any other reason, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, Submissions not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise.

By submitting a Submission, Nominator, Nominee and prize winner grant Sponsor and their affiliated companies worldwide, non-exclusive, perpetual, irrevocable, royalty-free, unconditional, and fully paid-up rights to publicly perform, display, broadcast, or transmit the Submission and/or the makeover (to include any videos, photos or written works of the makeover), in whole or in part, for promotion and marketing purposes worldwide in any and all forms of media, whether now know or hereafter devised, and to distribute (directly or indirectly through multiple tiers) the Submission and/or the makeover to Sponsor affiliates, its marketing agencies, and to third parties for

these purposes. Submission must be truthful in all respects. Nominator, Nominee and prize winner further agree and warrant that they may not submit any Submission that is known or that should be known at the time of Submission that (a) is false, inaccurate, or misleading; (b) infringes on any third party's copyright, patent, trademark, trade secret, or other proprietary rights or rights of publicity or privacy; (c) violates any law, statute, ordinance, or regulation (including, but not limited to, those governing export control, consumer protection, unfair competition, anti-discrimination, or false advertising); or (d) is or may reasonably be considered defamatory, libelous, hateful, racially or religiously biased or offensive, unlawfully threatening or unlawfully harassing to any individual, partnership, or corporation.

NON-QUALIFYING SUBMISSIONS: Submissions (a) containing general obscene, lewd, crude, vulgar, profane, defamatory or inappropriate text, including acts of violence or acts that appear to cause harm; (b) containing other offensive content and/or any content expressing explicit, graphic or excessive indecent content that is or could be considered inappropriate, unsuitable, or offensive; or (c) otherwise violate these Official Rules, as determined by Sponsor, in their sole discretion, will be disqualified from the Contest. Sponsor reserves the right to disqualify a Submission with offensive content or material that it feels inappropriate in any way. Each Submission submitted must be an original work, never previously published, manufactured or produced. Late Submissions or Submissions sent via any other method than those stated above will not be accepted.

JUDGING: The judging of Nominations will consist of two (2) phases:

- A. PHASE 1, judging by which all Submissions will be judged to determine to five (5) Finalists;**
- B. PHASE 2, judging by which prize winners are determined from the Finalists.**

Phase 1: On or about July 10, 2026, a Sponsor representative will judge all eligible Submissions received during the Contest Period based on the following criteria:

Authentic, Inspiring, Unique American Hero Story (70%)
Photo Submission (20%)
Grammar and Punctuation (10%)

Judges will "score" the Submissions based on a raw score between 1-5 (with 5 being the highest). For each Submission, after a (1-5) score has been determined for each criterion, each raw score will be "weighted", taking into account the relative percentages shown above (in parentheses, next to each criterion). The "total score" for each scored Submission will be the total score of all of the above criteria (taking into account the above-described "weighting"). The five (5) Submissions having the highest "weighted total score" will proceed to Phase 2 and each Nominee associated with each will be deemed a "Finalist". Finalists and the corresponding Nominee will not receive any prize for merely being selected as a Finalist. **Finalists will not be notified.** The Sponsor reserves the right, in its sole discretion, to select fewer Finalists for any reason whatsoever.

Phase 2:

Judges will "score" the Finalists based on a raw score between 1-5 (with 5 being the highest). For each Finalist, after a (1-5) score has been determined for each criterion, each raw score will be "weighted", taking into account the relative percentages shown above (in parentheses, next to each criterion). The "total score" for each scored Finalist will be the total score of all of the above criteria (taking into account the above-described "weighting"). The Finalist Nominations having the highest "weighted total score" will proceed to Phase 3 and each Nominee associated with each will be deemed a "Finalist". Finalists and the corresponding Nominee will not receive any prize for merely being selected as a Finalist. The Sponsor reserves the right, in its sole discretion, to select fewer Finalists for any reason whatsoever.

Authentic, Inspiring, Unique American Hero Story (70%)
Photo Submission (20%)
Grammar and Punctuation (10%)

Phase 3:

Judges will "score" the Finalists based on the same judging criteria, as set forth in Phase 2. To accomplish this, the judges will use the same scoring system to re-score each Finalist-related Nomination by assigning a 1-5 raw score to each criterion and, thereafter, "weighting" each such raw score, using the same percentages deployed in

Phase 2, then adding each weighted raw score to arrive at a “weighted total score”). The Finalist Nomination having the highest “weighted total score” will be deemed the “Grand Prize Winner”.

NOTE: In the event of a tie in any phase, an additional judge will score each tied Submission (pursuant to the procedures described above) and the Submission with the highest total score pursuant to *that subsequent scoring* will proceed to Phase 1 or Phase 2, respectively. In the event of a further tie as to Phase 1 or Phase 2, the Sponsor (as applicable) shall, in their sole discretion, choose a Finalist, Finalist or Grand Prize Winner (as applicable) based on its evaluation of which Nomination is superior overall, taking the entire judging criteria into consideration.

Sponsor reserves the right not to award a prize if, in its sole discretion, it receives an insufficient number of eligible and qualified Submissions. Prize awards are subject to verification of eligibility and compliance with the terms of these Official Rules.

PRIZES: There will be one (1) Grand Prize for the entire Contest. The Nominee will be the prize winner.

Grand Prize: Grand Prize Winner will receive: i) a 2026 Polaris RANGER CREW XD 1500 NorthStar Ultimate vehicle- 1776 Custom Build, and ii) a trip for two (2) to Nashville, TN from August 2, 2026 to August 4, 2026 (the “Grand Prize”). Total approximate retail value (“ARV”) of the Grand Prize is \$TBD.

Grand Prize Winner will receive a trip for two (2) to Nashville, TN August 2, 2026 to August 4, 2026 to include: i) roundtrip coach class airfare transportation for Grand Prize Winner and one (1) guest to/from Grand Prize Winner’s legal residence and a major commercial airport near Nashville, TN, ii) two (2) night hotel accommodations (double occupancy/standard room, room and tax only) at a hotel to be determined by Sponsor, and iii) two (2) tickets to the Polaris Powersports Dealer Meeting, and iv) \$2,500 to be used towards expenses and awarded as either cash or gift card by Sponsor. Any amount of expenses beyond the \$2,500 will be the sole responsibility of the Grand Prize Winner. All travel arrangements must be made through the Sponsor or Sponsor’s designee. The Grand Prize Winner must travel as and when designated by Sponsor or the Grand Prize may be forfeited. Grand Prize Winner will be responsible for all meals, transportation, excursions, tips or gratuities, fuel, parking, beverages, telephone calls, overages, baggage fees, extras and any other incidental costs or expenses not specifically stated herein as being included.

Grand Prize details, including trip dates are at Sponsor’s discretion. Grand Prize must be taken on the dates determined by the Sponsor. In the event the Grand Prize Winner is unable to travel on the dates determined by the Sponsor, the Grand Prize Winner will forfeit their right to the Grand Prize and no compensation will be awarded. Trip, events and experiences, travel and lodging elements selected by Sponsor may be subject to change due to impracticability or unavailability, or for any other reason as determined necessary by Sponsor or its designee, and are subject to any and all applicable health and safety protocols (which may be dictated by provider/location policies and/or state and/or local government requirements – all of which are subject to change at any time, including as the result of any pandemic). Tickets and certificates if any, are subject to the terms and conditions of issuer and will not be replaced by Sponsor if lost, stolen, misplaced, damaged or destroyed. Grand Prize ARV may vary, depending on the point, date and time of departure. Any difference between ARV and actual value will not be awarded as cash or otherwise. The Grand Prize Winner and their guest must possess all required travel documents, including visas and valid passports, if and as applicable. It is the responsibility of the Grand Prize Winner and their guest to provide proper documentation (including government issued picture identification). All aspects of the travel portions of the Grand Prize must be conducted on such dates as determined by Sponsor in its sole and absolute discretion. The dates of departure and return are subject to change at Sponsor’s sole and absolute discretion. Airline tickets are non-refundable/non-transferable and are not valid for upgrades. All airline tickets are subject to flight variation, work stoppages, and schedule or route changes. Sponsor reserves the right to structure travel route and select hotels in their sole and absolute discretion. The Grand Prize Winner will not receive cash or any other form of compensation if actual travel costs are less than the estimate made in these Official Rules. The Grand Prize is subject to seat and hotel availability, as well as Sponsor’s or prize provider’s terms and conditions generally applicable thereto. Grand Prize Winner must be accepted as a whole or will be forfeited in its entirety. Specific air carrier(s) and other trip specifics are selected at the sole discretion of the Sponsor. All travel is subject to availability; blackout dates and other restrictions may apply. Travel must originate and end at the same major gateway airport. Grand Prize Winner and guest must travel together on the same itinerary. Grand Prize Winner and guest will be required to obtain and maintain all insurance (including health, liability and any other insurance). Grand Prize Winner acknowledges and agrees that the Contest Entities are not providers/carriers of transportation, or insurance providers. No changes will be made

to travel details once any element(s) of the travel arrangements have been booked. No frequent flier miles will be earned on any element of the Grand Prize travel. Grand Prize conditions may be added or modified by Sponsor or its designee. Contest Entities are not responsible for any changes of any element of the Grand Prize, nor are they liable for any expenses incurred as a consequence of flight/event changes, cancellation or delays. Any unclaimed and/or unused element of the Grand Prize, or any element thereof, will remain the property of Sponsor or its designee. The Grand Prize restrictions/conditions stated herein are not all-inclusive and the described above may be subject to additional restrictions/conditions, which may be stated in the Affidavit (as defined herein), and/or other travel or release documents. Contest Entities are not liable for any missed prize events, opportunities or expenses incurred as a consequence of flight cancellation/delay or ground transportation delay. No refund or compensation will be made in the event of the cancellation or delay of any transportation or other prize element except at the sole and absolute discretion of Sponsor. Additional prize award details and travel information to be provided to the Grand Prize Winner at the time of Grand Prize award. The Grand Prize Winner may be required to provide a credit card at the time of hotel check-in. Guest of Grand Prize Winner must be at least the age of majority in their state/province of residence as of the date of departure. Once a guest is selected, he/she/they may not be substituted, except in Sponsor's sole and absolute discretion. Travel is subject to the terms and conditions set forth in this Contest, and those set forth by Sponsor's transportation carriers of choice.

In the event the Grand Prize Winner resides with a seventy-five (75) mile radius of the location, Grand Prize Winner and guest will receive roundtrip ground transportation in lieu of the airfare.

Grand Prize will be forfeited if Grand Prize Winner is unable to attend the event on the dates outlined above. Grand Prize Winner understands and agrees that Sponsor has the right, at their sole discretion, to disqualify and remove the Grand Prize Winner or the guest from the event at any time without compensation if the Grand Prize Winner's or their guest's behavior at any point is uncooperative, disruptive, or may or does cause damage to person, property, or the reputation of Sponsor or otherwise violates the policies of the Sponsor and in such a case, Grand Prize Winner will still be solely responsible for all taxes and other expenses related to the Grand Prize, if any. (Color, Options and Accessories to be determined at the sole discretion of the Sponsor). Vehicle may have mileage and Grand Prize Winner will be responsible for requesting any mileage on the vehicle. Grand Prize Winner will be solely responsible for any applicable registration, license, title and insurance fees, all taxes (federal, state, local, sales and/or income) and any expenses not listed herein related to the acceptance and use of the vehicle. Vehicle will have a standard factory warranty. SPONSOR MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, AS TO THE QUALITY OF CONDITION OF THE VEHICLE AND EXPRESSLY DISCLAIMS ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Grand Prize Winner is required to comply with any and all applicable federal, state and local laws, rules and regulations including, but not limited to licensing and insurance requirements. Any difference between stated MSRP and actual value of the vehicle will not be awarded.

Grand Prize Winner will take delivery of the vehicle at a Polaris dealer as designated by Sponsor within thirty (30) days of notification that prize is available. Grand Prize Winner must have or obtain and provide proof of liability insurance prior to the time of delivery of the Grand Prize. All travel-related expenses to the Polaris dealer are the

responsibility of the Grand Prize Winner. In the event of noncompliance, the Grand Prize will be forfeited, and an alternate potential Grand Prize Winner will be determined based on the Submission having the next highest score.

VEHICLE CONDITIONS: The Grand Prize Winner shall bear all risk of loss or damage to the vehicle after it has been delivered. The depiction of the vehicle in any advertising or promotional materials or physical display may not reflect the actual vehicle delivered to the Grand Prize Winner.

Sponsor will not replace any lost or stolen portion of the Grand Prize. **No more than the number of prizes as set forth in these Official Rules will be awarded.** Grand Prize Winner agrees that the prize is being provided “as is,” and the Released Parties (as defined in the “NO LIABILITY” section below) make no warranty, representation or guarantee regarding the Grand Prize, including but not limited to its quality, condition, merchantability or fitness for a particular purpose. Contest Entities are not responsible for any changes of any element of the Grand Prize, nor are they liable for any expenses incurred.

NOTIFICATION: POTENTIAL GRAND PRIZE WINNER WILL BE NOTIFIED WITHIN SEVEN (7) DAYS OF VERIFICATION BY A SPONSOR REPRESENTATIVE OR THE INDEPENDENT ADMINISTRATOR VIA PHONE (THE “NOTIFICATION”). The Sponsor Representative or Independent Administration will make two (2) attempts to notify the potential Grand Prize Winner within a 24 hour time frame. In the event that: (a) the potential Grand Prize Winner fails to respond to the Notification; (b) the potential Grand Prize Winner fails to supply the Required Documents (as defined in the “PRIZE CLAIMS” section below); (c) any Notification is returned as undeliverable; (d) Grand Prize Winner fails to provide a photo, proof of age, identity, residency of eligibility; and/or (de) it is determined by the Sponsor, in their sole discretion, that the potential Grand Prize Winner is not eligible in accordance with these Official Rules, such potential Grand Prize Winner will be disqualified and an alternate Grand Prize Winner will be selected based upon the Submission receiving the next highest score in the respective Phase.

Sponsor and its agents are not responsible for lost, late, incomplete, incorrect, damaged, misdirected, or any condition caused by events beyond the control of the Sponsor that may cause the Contest to be disrupted or corrupted. Sponsor may prohibit a Nominator and/or Nominee from participating in the Contest or winning a prize if, in its sole discretion, it determines that said person is attempting to undermine the legitimate operation of the Contest by cheating, deception, or other unfair playing practices or intending to annoy, abuse, threaten or harass any other persons, Sponsor, or Independent Administrator. As a condition of participating in this Contest, each Nominator and Nominees agrees that any and all disputes that cannot be resolved between the parties and causes of action arising out of or connected with this Contest shall be resolved individually, without resort to any form of class action, exclusively before a court located in New York, having jurisdiction over the parties and the subject matter.
