

## 2021 POLARIS® RIDE COMMAND MILLION MILE GIVEAWAY COMPLETE OFFICIAL RULES

**1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** Open only to legal residents of the United States, District of Columbia or Canada who, at the time of entry are **registered Trail Managers, or Trail Data Contributors in the Ride Command Program, who have contributed information between January 1, 2021 and September 30, 2021**, are 18 years of age or older and who have reached the age of majority in their state or province of residence. Void outside the U.S. or Canada or where prohibited or restricted by law. This Giveaway ("Giveaway") is subject to all applicable federal, state, and local laws and regulations.

Potential winners are notified by email and telephone.
