

## 2021 POLARIS® HOLIDAY ADVENTURE SWEEPSTAKES COMPLETE OFFICIAL RULES

**1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** Open only to legal residents of the 50 United States or District of Columbia who, at the time of entry, are 18 years of age or older and who have reached the age of majority in their state of residence. Void outside the U.S. or where prohibited or restricted by law. This Sweepstakes ("Sweepstakes") is subject to all applicable federal, state, and local laws and regulations.

**2.
