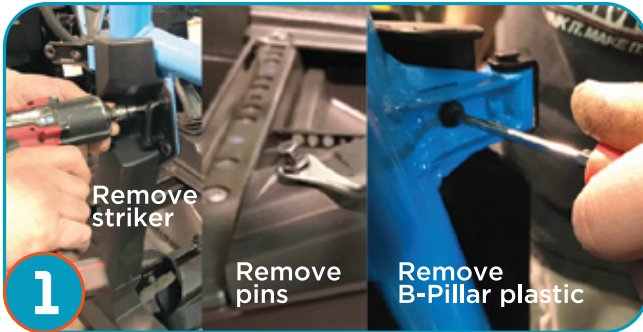




XP4 Asylum Cab-Only Cage Instructions (P194C026/P194C028) (P188C047/P188C048)

*****NOTE: Prior to installation, please verify if a revised version of this instruction sheet is available on proarmor.com.*****

- Vehicle Preparation
1. Remove seats, doors with hinges, harnesses and B-Pillar plastics from stock cage.
 2. Save all removed hardware to re-attach your new cage.



1 Remove the hardware that attaches the existing roll cage to A-B-C-D pillars on the chassis of the vehicle. Remove B-Pillar plastics as shown. Save all of this hardware, you will need it to attach the new Pro Armor cage.



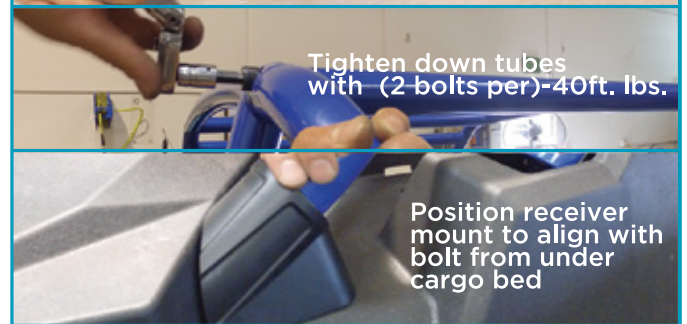
2 Once all hardware is removed, detach and remove the old cage and place Pro Armor cage on vehicle. It takes two, preferably 3, people to safely handle the cage on and off vehicle.



3 Once new cage is in place, attach the Pro Armor cage to the vehicle chassis using the existing hardware at the A, B, D pillars (Hand tighten). You will want to take this time to install your Pro Armor harnesses lap belts.



4 Place receiver mount on down tube (x2)
Place O-ring on down tube (x2)



5 Tighten down tubes with (2-bolts per)-40ft. lbs.
Position receiver mount to align with bolt from under cargo bed



6 Depending on what doors you have, re-install your doors. Once doors are in place, check the fit and alignment of the Pro Armor cage.

Place provided receiver mount, found in hardware kit along with o-ring onto rear down tube bars (x2) to be installed in the rear cargo area. Attach down tubes to cage bungs and align receiver mount. Install supplied bolt and washer at bottom cargo area into receiver mount. (If installing on a Turbo S, use existing stock hardware already on vehicle).

Firmly tighten all hardware to vehicle manufacturer's torque specs to secure the cage firmly to the chassis. Re-install mounting hardware for B-Pillar plastics.

There should be no unused hardware from your existing cage left over. All bolts and hardware should be tightened, and the cage should be periodically inspected before use to ensure that the cage remains affixed securely to the vehicle chassis. The primary purpose of a UTV cage is to reduce the possibility of a seat-belted operator or passenger being crushed in a vehicle roll over. The Pro Armor (Cage) is certified to meet ANSI/ROHVA-1 Roll over Protective Structure (ROPS) standards.
2. If you have any questions about your installation or are unable to complete installation, contact Pro Armor Customer Service or have an authorized dealer or trained technicians inspect your installation. Do NOT use your UTV if installation of the cage is incomplete.
3. The Pro Armor (Cage) is designed to work with Pro Armor seat belts, along with proper preparation and responsible driving from the driver. Pro Armor recommends you follow all manufacturer instructions when preparing to ride and during operation.
4. Please periodically inspect the roll cage and bumper hardware for tightness. Do not use if hardware is loose or missing and if the cage is not affixed properly and securely tightened to UTV frame.
5. Never use the vehicle without the cage securely in place.
6. Never stick hands, head or arms outside of vehicle at any time when it is in motion.
7. Always wear and use proper safety equipment when using any Pro Armor product.
