

2024 POLARIS® CAMP RZR GLAMIS SWEEPSTAKES COMPLETE OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

2. SWEEPSTAKES DATES: The “2024 Polaris® CAMP RZR” Sweepstakes (the “Sweepstakes”) begins at 8:00am Pacific Time (“PT”) on November 1, 2024 and ends at 11:59pm PT on November 2, 2024 (the “Sweepstakes Period.”) Sponsor’s computer will be the official time clock for the Sweepstakes.

3. ELIGIBILITY: The Sweepstakes is open to: i) legal permanent residents of the forty nine (49) United States and the District of Columbia (excluding Alaska) who are eighteen (18) years of age or older or the age of majority in his/her state of residence, or ii) a legal resident of Canada (excluding residents of the province of Quebec) and at least the age of majority in his/her province or territory of residence at the time of entry (the “entrant”) and in attendance at the Camp RZR event at the Glamis Imperial Sand Dunes (the “Event”). Persons in any of the following categories are **not** eligible to participate or win a prize: (a) persons who, since October 1, 2024 were or are employees, officers, directors or agents of Polaris Industries, Inc. (the “Sponsor”) or National Sweepstakes Company, LLC (the “Independent Administrator”); their parent companies, affiliates, subsidiaries, or dealers; or the service agencies of any of the above organizations; (b) individuals engaged in the development of, the production or distribution of materials for, or the implementation of this Sweepstakes (collectively “Released Parties”); or (c) employees of, persons in the immediate family of, or persons living in the same household as any person in any of the preceding categories. For the purpose of this Sweepstakes, “immediate family members” are defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children, and grandchildren. Void in Quebec and Alaska and outside the forty-nine (49) United States, Canada and where prohibited or restricted by law. By participating in this Sweepstakes, entrants accept and agree to be bound by these Official Rules and the decisions of Sponsor, which shall be final on all matters. Sponsor reserves the right to modify the Official Rules of the Sweepstakes in any way at any time, subject to state or federal law.

4. HOW TO ENTER:

While in attendance at the Event, visit one (1) of the four (4) Polaris Experience Areas to complete the entry form on an iPad to receive a Polaris Star Card with a QR Code or scan their Star Card to receive an entry. Entrant will need to complete: full name, complete address, zip/postal code, phone and email address. When your entry is complete, click Submit (once submitted, entry cannot be deleted, canceled, or modified). Limit of one (1) entry per person per Polaris Experience Area for the Sweepstakes. Total of four (4) entries per person for the entire Sweepstakes.

You may enter the Sweepstakes under one name and one email address only. Each entry must be manually key stroked and manually entered by the individual entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified.

Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that entrant’s entry and that entrant may be disqualified from the Sweepstakes.

In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed submitted by the person in whose name and mailing address were submitted via the entry form (the “Authorized Account Holder”). A potential prize winner may be required to show proof of being the Authorized Account Holder. If the Sponsor cannot determine the identity of the person based upon the information

submitted via the entry form, the respective entrant will be disqualified. Sponsor will not verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged entries.

Entrant must notify Sponsor of any changed contact information within the Sweepstakes Period to remain eligible to win based on entry information. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person.

5. DRAWING/ODDS: On or about November 4, 2024, at 2:00pm ET in Newark, NY, three (3) prize winners will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. The odds of being selected as a prize winner is dependent upon the number of eligible entries received during the Sweepstakes Period. The random drawing and determination of the prize winners will be conducted by a Sponsor representative whose decisions are based upon their sole discretion of these Official Rules and are final and binding in all respects.

6. PRIZE NOTIFICATION/CLAIM: Award and confirmation of the prize winners is contingent upon the prize winners' qualifications and compliance with these Official Rules. Potential prize winners will be notified by email and telephone (the "Notification"). Potential prize winners must respond to the Notification within the time frame indicated by providing a completed Affidavit of Eligibility/Liability/Publicity Release Form and an IRS Form (the "Required Documents"). If the potential prize winner is a legal resident of Canada (excluding Quebec), he/she will be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question. Sponsor reserves the right, in its sole discretion, to disqualify and randomly select an alternative potential prize winner if: (a) the potential prize winner does not respond within the Notification timeframe; (b) the Notification is returned as undeliverable; (c) the potential prize winner fails to provide Sponsor with satisfactory proof of age, identity, residency or eligibility or provide the Required Documents; (d) the potential prize winner declines acceptance of the prize; (e) if in Sponsor's determination, the potential prize winner has not complied with these Official Rules or (f) if potential prize winner who is a resident of Canada (excluding Quebec) does not answer the required skill question correctly. In the event that the potential prize winner is disqualified for any reason, Sponsor shall have no liability or obligation to such individual.

The prizes are taxable as income and each prize winner is solely responsible for any taxes on their prize, including, but not limited to all applicable federal, state, provincial and local taxes. A third party must report the value of the prize to the IRS in the year the prize is received by each prize winner and will be reported to each prize winner and the IRS in the form of a Form 1099(US Residents) or Form 1042-S (Canada Residents).

7. PRIZES: There are a total of three (3) prizes to be awarded (each a "Vehicle Prize").

One (1) prize winner will receive a RZR Pro R 4 Limited Edition Off-Road Vehicle having an ARV of up to \$49,999USD/\$67,815CAN.

One (1) prize winner will receive a RZR Pro R 4 Ultimate Off-Road Vehicle having an approximate retail value ("ARV") of up to \$46,999USD/\$63,746CAN.

One (1) prize winner will receive a Youth RZR 200 having an ARV of up to \$6,799USD/\$9,222CAN.

Total ARV of all prizes to be awarded is \$103,797USD/\$140,783CAN.

Color, Options and Accessories for each Prize Vehicle to be determined at the sole discretion of the Sponsor. Each prize winner will be solely responsible for any applicable registration, license, title and

insurance fees, all taxes (federal, state, local, provincial, sales and/or income) and any expenses not listed herein related to the acceptance and use of the Vehicle Prize. Each Vehicle Prize will have a standard factory warranty. SPONSOR MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, AS TO THE QUALITY OF CONDITION OF THE VEHICLE AND EXPRESSLY DISCLAIMS ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Each prize winner is required to comply with any and all applicable federal, state and local laws, rules and regulations including, but not limited to licensing and insurance requirements. Any difference between stated MSRP and actual value of the Prize Vehicle will not be awarded.

Each prize winner will take delivery of their Vehicle Prize at a Polaris dealer as designated by Sponsor within thirty (30) days of notification that Vehicle Prize is available. Each prize winner must have or obtain and provide proof of liability insurance prior to the time of delivery of the Vehicle Prize. All travel-related expenses to the Polaris dealer are the responsibility of each prize winner. In the event of noncompliance, the Vehicle Prize will be forfeited, and an alternate prize winner will be selected from the remaining eligible entries received during the Sweepstakes Period.

10. DISPUTES: THIS SWEEPSTAKES IS GOVERNED BY THE LAWS OF THE STATE OF MINNESOTA WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in this Sweepstakes, each entrant agrees that any and all disputes that cannot be resolved between the parties and causes of action arising out of or connected with this Sweepstakes shall be resolved individually, without resort to any form of class action, exclusively before a court located in Minnesota, having jurisdiction over the parties and the subject matter. Further, in any such dispute, under no circumstances will participant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than participant's actual out-of-pocket expenses (i.e., costs associated with entering this Sweepstakes), and participant further waives all rights to have damages multiplied or increased.
