

2021 POLARIS® RZR TRAIL COLLECTIONS SWEEPSTAKES COMPLETE OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ENTER ONLINE ONLY BETWEEN APRIL 12, 2021 AND MAY 10, 2021. Open only to legal residents of the **United States, District of Columbia and Canada (excluding Quebec)** who, at the time of entry, are 18 years of age or older and who have reached the age of majority in their state or province of residence.
