2025 SLINGSHOT SUMMER GETAWAY SWEEPSTAKES Complete Official Rules

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

2. SWEEPSTAKES DATES: The "Slingshot Summer Getaway Sweepstakes" (the "Sweepstakes") begins at 12:00am Eastern Time ("ET") on June 1, 2025 and ends at 11:59pm ET on August 31, 2025 (the "Sweepstakes Period.) All entries must be received during the Sweepstakes Period to be eligible. The Sweepstakes Period is subject to change at Sponsor's discretion if for any reason the Sweepstakes cannot be conducted as planned.

3. ELIGIBILITY: The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who, at the time of entry are 18 years of age or older and who have reached the age of majority in their state of residence (the "entrant"). Limit one (1) entry per person per test ride. You may enter the Sweepstakes under one name and one address only. Once submitted, entries become the property of Sponsor and will not be acknowledged or returned.

6. PRIZE DETAILS: Prize winner will receive a Polaris Adventures rental for winner and one (1) guest to include: i) roundtrip coach class airfare to and from a major airport nearest their permanent residence and location destination in the United States (see below for a list of locations, ii) one (1) hotel room accommodation for three (3) days/two (2) nights, room will be a standard double occupancy room (Sponsor to determine the hotel accommodations at their discretion and is inclusive of room rate and tax only), iii) Polaris Adventures rental (baring restrictions/qualifications of chosen adventure), and iv) gift card to be used towards any other expenses (the "Grand Prize"). Trip, travel, and lodging elements may be subject to change due to impracticability or unavailability, or for any other reason as determined necessary by Sponsor or its designee. Sponsor reserves the right in their sole discretion to disgualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Sponsor reserves the right to disgualify or reject any incomplete, inaccurate or false entry.
