## 2018-19 Timbersled Contingency Program

- Certain Restrictions Apply
- Must be a minimum of 4 entries that start the final in each class to qualify
- Race Association must submit rules for approval prior to race season
- Race Association must submit full results to Polaris Race Dept. within one week of the event
- Racer must submit completed contingency form to Polaris Race Dept within seven days of race event for payment. A separate contingency form must be submitted for each win being claimed
- Point Championships will only be paid for overall class results, not a Saturday and Sunday Champion
