

2020 TIMBERSLED® RIDE WITH US SWEEPSTAKES COMPLETE OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ENTRY FORM IS AVAILABLE ONLINE BETWEEN September 6, 2020 AND November 13, 2020.
